INCENTIVES

Industrial Property Tax Abatement (PA 198)

Local financing tool that decreases real property taxes by 50% for up to 12 years.

Jobs Ready Michigan Program

State grant assistance for talent recruitment and job training in high-impact occupations.

Muskegon County EPA Grant

Funds for this grant are distributed by GMED for the purpose of environmental assessments on sites that are suspected of having contaminants throughout Muskegon County.

Michigan Business Development Program

State grant assistance for the creation of qualified new jobs or investment.

Commercial Facilities Exemption (PA 255)

Local tax incentive that freezes taxable value for a period of up to 12 years.

Opportunity Zones

A federal tax incentive program found in the Tax Cuts and Jobs Act of 2017 to spur private investment and economic activity in specific distressed or low-income census tracts. Muskegon County has five Opportunity Zone census tracts – three in the city of Muskegon and two in the city of Muskegon Heights – as designated by the State of Michigan.

Brownfield Redevelopment Financing (PA 381)

Generates new tax revenue, & those new taxes can be captured by a local Brownfield redevelopment authority and given back to the developer to reimburse them for the eligible costs associated with redeveloping the property. Brownfield tools can now also be utilized for housing developments.

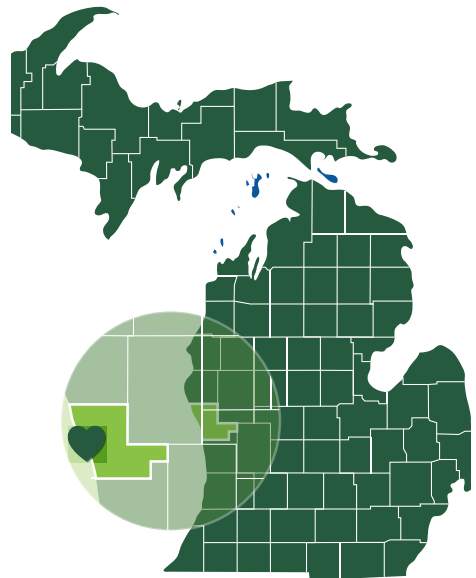

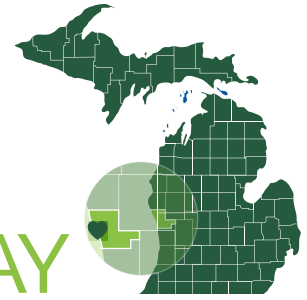

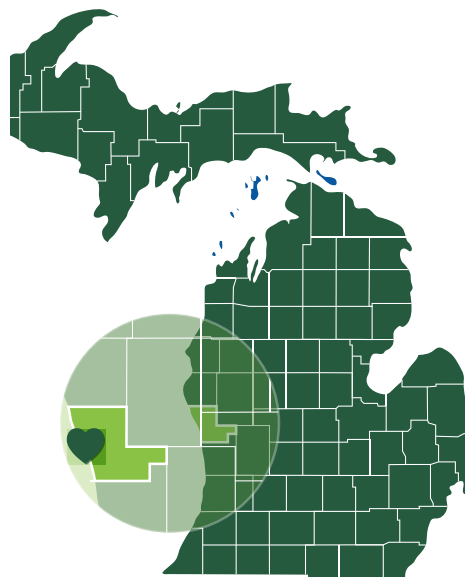
